## FINAL ORDER

The parties have come before the Court to advise it that they have, by agreement, resolved all the matters in controversy. Plaintiffs submitted Requests for Religious Accommodations on November 26, 2024. On December 6, 2024, Defendant granted Plaintiffs' requests for religious accommodations. In granting the accommodation requests to Plaintiffs, Defendant maintains that: (1) HCPS does not require that staff ask students to share their pronouns; (2) HCPS does not require staff to use a preferred name or pronoun; and, (3) HCPS does not support hiding or withholding information from parents. The Parties further agree that Defendant will continue to inform staff—through training, posting on Defendant's website, or another appropriate method—that similar accommodations are available to employees. Based on this agreement of the parties:

IT IS HEREBY ORDERED that the Complaint is DISMISSED WITH PREJU-DICE and Plaintiffs' Motion for Summary Judgment and Motion to Strike Defendant's Jury Demand are MOOT.
